They must submit non refundable participation fee of Rs.1000/- (Rupees one thousand only) by Demand Draft drawn in the favour of **‘The Registrar, University of Delhi’** payable at **Delhi** along with EOI documents under a sealed envelope superscribed with **“Expression of Interest (EOI) for 3D Scanner”** by post or handed over to the office of the undersigned on or before **June 14, 2016 by 15:00 Hrs.**

## **1. Introduction**

Cluster Innovation Centre, University of Delhi intends to set up a Rapid Prototype Lab to facilitate mock up and design process. Original Equipment Manufacturers (OEM) or their authorized distributors or vendors/suppliers, who have adequate credential for supply, installation and maintaining 3D Scanner may submit EOI for the purpose.

## **2. Eligibility Criteria**

- I. Name, address and contact details of present and past satisfactory services of **minimum three clients** to whom such equipments have been supplied.
- II. The OEM or their authorized distributors or vendors/ suppliers should have at least **five years of experience** in similar volume of works of supply, installation and maintenance of 3D Scanners.
- III. A **Certificate** (notarised affidavit in Rs. 10 Stamp Paper) to be signed by MD/ CEO/ authorized signatory of the company that they have never been debarred or blacklisted for any services, supplies or products dealing in, by any organization or educational institutes/ universities.
- IV. **Turnover and Profit:** Average annual financial turnover should be at least 3 times of the estimated cost during the immediate last 3 consecutive financial years (ending with March 2016). Summary of annual average turnover and net worth (copy of audited statement of accounts/ balance sheet for the last three financial years ending with March 2016) be submitted. The company must be profitable during all these three years.
- V. The suppliers should be enough capable of demonstrating the proposed system at Cluster Innovation Centre, University of Delhi.

## **3. Scope**

The Cluster Innovation Centre, University of Delhi is planning to equip a Rapid Prototype Lab and intends to purchase 3D Scanner meeting following requirements:

1. High resolution camera and projector based system
2. System must be suitable for inspection and reverse engineering
3. Having automatic calibration and measurement features
4. User friendly and safe
5. Capable of scanning high range of part sizes and different material types
6. User friendly software capable of automatic calibration, scanning, inspection, smart editing, stitching, visualization and support various 3D file format

#### **4. General Note**

- I. The OEM or their authorized distributors or vendors/ suppliers must submit the documentary proof in support of meeting the eligibility criteria. Simply an undertaking by the vendors for any item of the criteria shall not suffice the purpose. All the documentary proof must be listed on the letter pad of the company and enclosed in a cover to be submitted with the EOI proposal. Original product brochure must be submitted to corroborate this.
